To evaluate risk and settlement value, legal practitioners need to quickly and accurately estimate the scope of electronic discovery, prepare for Meet & Confer conferences, and assess case facts, demonstrating that early case assessment (ECA) is a requirement. Analyze emails, attachments, and documents in minutes: The eDiscovery Platform is quickly and easily installed, allowing legal teams to begin their electronic discovery process sooner and understand the context of the case across the collected data set. As a single application for the entire electronic discovery lifecycle, the eDiscovery Platform is capable of collecting from all critical enterprise data sources, processing data immediately and beginning analysis without moving data between multiple standalone tools. Consequently, legal teams gain earlier access to the case, allowing them to make informed decisions from the onset of a legal matter.

Rapidly collect data in a defensible manner: During the collection process, the eDiscovery Platform verifies the integrity of the data before and after collection,

ensuring data is forensically sound and providing a defensible audit trail that can be used to document chain of custody. The collection capability also allows either IT or legal teams to easily collect custodial data from multiple critical data sources including email servers, employee computers, file servers, Microsoft SharePoint®, and applications in the cloud.

Accurately scope eDiscovery budget and timeline: The eDiscovery Platform Pre-Processing Analytics visually summarize overall document set characteristics and present detailed analysis by custodian, timeline, volume, and file type. This rapidly confirms that all case data has been collected and provides detailed statistics used to accurately estimate an electronic discovery budget and timeline.

Discover exactly who knew what, and when:

The Discussion Thread feature links all related messages including all replies, forwards, CC's and BCC's, and provides a chronological thread of an entire discussion. By tracing the thread, legal professionals can identify all participants involved and determine who knew what and when.

Conceptually understand the data: Uses can quickly analyze all documents related to a single subject. Topic clustering utilizes patent pending linguistic algorithms to automatically organize documents into specific topics.

Quickly discover the most relevant evidence to your case: Transparent Search delivers a new set of search features that enable a more defensible and collaborative electronic discovery search process. Users are able to avoid excessive false positives and quickly




Figure 1. Discussion Threads Automatically links emails into threads enabling rapid analysis and identification of case facts.

identify relevant data. The identification of pertinent information is further accelerated with the Find Similar feature which allows reviewers to easily identify and view items with similar content to the document under review, exposing the scope of an idea across the entire case.

Rapidly complete first-pass review: Decision-Tree Tagging allows individual items (for example, emails, loose files, attachments, or embeddings) or sets of documents to be tagged using a multi-layer tree structure. This directs reviewers to key decision points, preventing errors and minimizing the number of clicks needed to accurately tag a document. Attorneys can review documents online in native format without requiring each application to be loaded on a workstation thereby streamlining the early case assessment process.

Quickly identify all custodians: With

the People Analytics feature, analysis of individual and group-to-group communications within a company, to customers, suppliers, and partners allow users to easily establish a list of top custodians for a specific search. In addition, the eDiscovery Platform Term Analytics leverages natural language algorithms to analyze noun phrases, which help users uncover secret project names and code words that may be relevant to a case or investigation.

Effectively prepare for the Meet & Confer:

Having the ability to easily sample and test keyword searches in preparation for the Meet & Confer. is critical. The eDiscovery Platform automatically generates search reports that




Figure 2: Pre-Processing Analytics: Provides data statistics prior to processing enabling accurate case budget and timeline estimates.
