Zones began as a promising technology catalog company in 1986. The company quickly grew to employ 200+ people in the U.S. More than 30 years later, Zones is now a global provider of comprehensive IT solutions reaching 80+ countries and employing 2,000+ people worldwide.

Like any growing company, Zones has adopted new technology and processes that enable them to work more efficiently. Some "legacy processes" were slower to change than others, however.
