Canadian customers must be registered with the Canadian Revenue Agency, in accordance with the Excise Tax Act (ETA), subsection 123(1) and 259(1). Organizations must demonstrate their qualifying tax status with documentation before orders can be placed.

How can my organization make purchases through the Adobe Nonprofit Licensing Program?

Nonprofit organizations interested in purchasing products should contact one of the authorized Adobe nonprofit and academic resellers. A list of authorized resellers can be found online at www.adobe.com/buy.

Resellers are required to verify customer eligibility prior to sale, either through securing a copy of eligibility certification or by verifying the organization through the IRS or Canadian Revenue Agency registry.

Nonprofit licenses are for the exclusive use of the eligible purchasing agency and cannot be resold. Nonprofit licenses may not be exported outside the United States and Canada nor sold or transferred to affiliates outside the United States and Canada.
